REVISED GUIDELINES FOR IMPLEMENTATION OF RANDHANIYOTI SCHEME IN THE STATE OF ASSAM.

OBJECTIVE :

The Scheme Randhanjyoti was launched on the 15th August, 2003. This scheme reflects the commitment of the Govt. of Assam to ensure provision of domestic LPG connections to widows, woman member of the Self-Help Group (SHG)andany other female member of the BPL families so as to serve 1 lakh poorest of the poor families in the rural and urban areas of the state. The Govt. of Assam has decided to expand the Randhanjyoti Scheme this year (2014-15) to cover an additional Nos. of beneficiaries to reduce the dependence on forests for firewood, to improve the environment by preventing the felling of trees, to provide relief on women from drudgery from cooking with firewood and to create a hygienic environment in the BPL families. The additional No of beneficiaries will be selected on the basis of the available targeted fund in the budget.

SELECTION CRITERIA:

In order to identify the beneficiaries, the following criteria to be adopted.

- 1. Widow of a poor family Woman member of a Self-Help Group
- 2. Any other female member of BPL families
- 3. Landless agriculture laborers, marginal farmers, both Urban & Rural artisans, slum dwellers and persons earning their livelihood on daily basis and other similar categories both in Rural & Urban areas.
- Households headed by widows or terminally ill persons/disabled persons
 having no assured means of subsistence or societal support.
- Widows or terminally ill persons/disabled persons/single woman with no family or societal support or assured means of subsistence.

IDENTIFICATION OF ADDITIONAL BENEFICIARIES:

The most crucial factor for ensuring the success of expandedRandhanjyoti Scheme will be the proper identification of beneficiaries in the above mentioned priority Groups. At present, in the State of Assam 1, 79,484 Nos. of beneficiaries have beer benefited under the Scheme. It has been decided to cover more beneficiaries in the State The identification of the additional Randhanjyoti beneficiaries shall have to be carried ou by the District Administration / Autonomous Councils from amongst the BPL families a present enjoying benefits of TPDS scheme or such other schemes of Panchayat and Rura Development Department within their respective Districts, but do not have any LP connection in their kitchen from any Government Oil Company, and also, not yet bee covered under the existing Randhanjyoti Scheme.

The following steps are suggested for proper identification of addition Randhaniyoti beneficiaries.



- a) The Numbers of additional Randhanjyoti beneficiarles will be finalized on the basis of the targeted allocation of fund. The Deputy Commissioners/-Principal Secretaries of Councils will distribute their allotted numbers among the Development Blocks and Gaon Panchayats for rural areas; circles and Urban Local Bodies(ULB) in urban areas, keeping in view of the priority Groups indicated above.
- b) The Deputy Commissioners/ Principal Secretaries of Councils will start the process of identification of beneficiaries after giving wide publicity, so that people are aware of the process and procedure adopted for identification of beneficiaries under the scheme.
- c) The Deputy Commissioners/ Principal Secretaries of Councils will utilize the services of all the District Level Officers concerned for supervising the process of identification in various Developmental Blocks.
- d) At the Block Level, each Panchayat may be assigned to an Officer of Revenue Department or some other Department who would be held accountable for proper identification of beneficiaries.
- e) In each Panchayat, in the first phase, a tentative. list of the beneficiaries may
 be drawn up keeping in view of overall numbers of the households allotted
 to the Panchayat
- f) in the case of urban areas, the Deputy Commissioners and the Principal Secretaries of Councils will also undertake a similar exercise by involving the Urban Local Bodies. The preliminary identification may be done Ward, wise by the Chief Executive of the Urban Local Body with the help of the Officers/Officials working under him.
- g) in cases where elected bodies in Rural/Urban areas are not in position, the Deputy Commissioners/Principal Secretaries of Councils will evolve a suitable mechanism for identification of beneficiaries in an impartial and objective manner.
- The free LPG connection under Randhanjyoti will be issued only in the name of senior most female member of the identified beneficiary family of 8Pi. category.
- The identified beneficiary family should be financially capable to purchase subsequent refill LPG cylinder at a price fixed from time to time by the Government of India in the Ministry of Petroleum and Natural Gas, New Deihi under the Direct Benefit Transfer of LPG (DBTL) scheme and must have a Bank Account in the local branches of the Banks scheduled in the scheme. Ignoring of this aspect may lead to futile the selection of a beneficiary family.

j) The selected beneficiaries have to provide three copies of passport size photos, one of which shall be attached in the register maintained in the LPG Distributor's office and the remaining two copies shall be at the panchayat/municipal office and at DC/SDO® FCS&CA branch respectively.

COMPONENT TO BE PROVIDED TO SELECTED BENEFICIARIES:

The additional identified beneficiaries would be provided with the following equipments under the Randhanjyoti Scheme:

- 1. One LPG single burner (ISI) marked.
- 2. Two nos. of domestic LPG cylinder (14.2 kg.)
- 3. One pressure regulator (ISI marked)
- 4. One connecting tube (ISI marked)
- 5. One blue book with security voucher.

For releasing the LPG connection to the selected beneficiary, the Gov will bear the cost of the following:

- 1. Security money for two domestic LPG cylinders
- 2. Security money for one Pressure Regulator
- 3. One single L.P.G. Burner (ISI marked)
- 4.One connecting Rubber Tube/ Suraksha tube
- 5. Cost of two LPG Refill
- 6. Cost of Blue Book
- 7. Administrative charges

ISSUE OF EQUIPMENTS:

After the identification of beneficiaries all the equipments having ISI standar will be provided to the beneficiaries free of cost for the first time by the designate authority.

ALLOCATION OF FUND:

Once the list of beneficiaries are finalized, the allocation of fund will be made by the Govt. of Assam and the same will be released by the Directorate of Food, Chasupplies & Consumer Affairs Centrally for purchase of equipments for distribution to the Randhanjyoti beneficiaries.

The Govt. of Assam expects that the Deputy Commissioners/ Princip Secretaries of Councils shall complete the Identification of beneficiaries under the expanded Randhanjyoti Scheme within 3 (three) months. Proper Identification Randhanjyoti beneficiaries from the priority Groups will be the key to the success of the expanded Randhanjyoti Scheme. The Deputy Commissioners/ Principal Secretaries Councils endeavor should be that only the deserving and the needy are identified and the get the benefits of the expanded Randhanjyoti Scheme.

The State Govt. will allocate fund on receipt of the Utilization Certificates of till funds allotted in the previous years.

It is, therefore, expected that the Deputy Commissioners/ Principal Secretari will furnish the Utilization Certificate of the amounts sanctioned so far for implementati of the scheme to their respective districts at the earliest.
